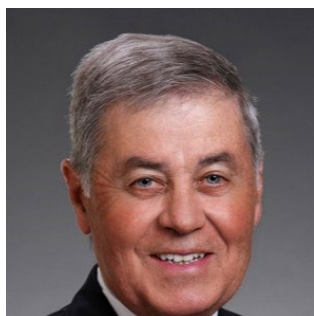

*Banking Industry Advisor, Salesforce*

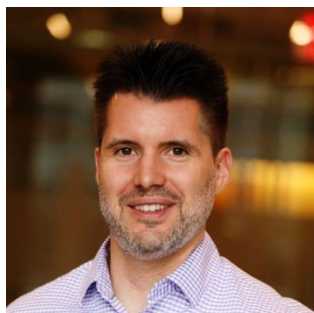
